

# **50 YEAR LIMITED WARRANTY**

## What does this Warranty cover?

This limited warranty covers any manufacturing defects in our concrete building products ("Product") reported to us while the warranty is in effect, subject to the exceptions stated below. This warranty is in lieu of all other warranties express or implied other than warranties implied by state law.

### How long does this coverage last?

This warranty lasts for a period of fifty (5D) years from the date the Product is purchased. This warranty extends only to the original purchaser of our Product and is not transferable. "Original purchaser" means the purchaser and the initial owner of the building or structure to which the Product is installed.

#### What will we do?

If our Product is found to be defective, at our option, we will either 1) repair or replace the defective Product; or 2) reimburse the original purchased price for the Product.

#### What will we not do?

We will not pay for any incidental or consequential damages resulting from a defect in the Product. Examples of incidental and consequential damages include the cost to repair or replace other property damaged as a result of the defect, loss of use of the Product and loss of time. We will not be responsible for any costs of removing the defective Product or installing the replacement Product.

### How can this warranty become void?

- \* Do not provide a proof of purchase
- \* Do not notify us of a potential defect as provided in the section "How do I get warranty service?"
- \* Failure to install the Product in accordance with local building codes, industry custom, or our instructions
- \* Failure to use 2.5 pound metal lath as the installation surface for the Product
- \* Install the Product closer than 4 inches to an earth surface or closer than 2 inches to a paved surface
- \* Move the Product from its original installation location
- \* Using the Product for foot traffic, such as a paver

#### What does this warranty not cover?

- \* Damage resulting from building settlement or wall movement
- \* Discoloring due to contaminates, staining, algae, oxidation, run-off from other building materials or contact with paint or other chemicals, such as sealers
- \* Damage resulting from misuse, abuse, accident, fire, water seepage, flood, vandalism, acts of God or other contingencies beyond your control
- \* Variations in color of the Product such as occur in natural stone

### How do I get warranty service?
